**ARTICLE I**  
**Adoption of Code**  
**[Adopted 4-3-89 as L.L. No. 4-1989]**

Be it enacted by the Village Board of the Village of Canisteo as follows:

**§ 1-1. Legislative intent.**

In accordance with Subdivision 3 of § 20 of the Municipal Home Rule Law, the local laws, ordinances and certain resolutions of the Village of Canisteo referred to in § 1-2 below shall be known collectively as the "Code of the Village of Canisteo," hereafter termed the "Code," and the various parts and sections of such local laws, ordinances and resolutions shall be distributed and designated as provided and set forth in § 1-2 of this Article. Wherever reference is made in any of the local laws, ordinances and resolutions contained in the "Code of the Village of Canisteo" to any other local law, ordinance or resolution appearing in said Code, such reference shall be changed to the appropriate chapter title, chapter number, Article number or section number appearing below, as if such local law, ordinance or resolution had been formally amended to so read.
